#### 1. Certification and Agreement

The institution, The Chrysm Institute of Esthetics, OPE ID #: 042204-00, has signed and returned to the Department of Education, the Certification and Agreement, and the assurance that the institution has used 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

#### 2. Student Portion of Grant Amount Received

The institution received \$71,012 on April 24, 2020 from the Department of Education pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to students (student portion only).

#### 3. Total Amount of Emergency Financial Aid Grants Distributed to Students

As of April 24, 2020, The Chrysm Institute of Esthetics has disbursed \$71,012.44 in Emergency Financial Aid Grants to students.

#### 4. Estimated Total Number of Eligible Students

As of April 24, 2020, The Chrysm Institute of Esthetics had estimated 138 students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act.

These students meet the following requirements:

- Must be US Citizen or Eligible Non-Citizen
- Must have a valid SSN
- Must be registered with Selective Service, if applicable
- Must have a HS Diploma or recognized equivalent

Students are required to report citizenship status, provide social security card, and submit HS diploma (or equivalent) at the time of application prior to enrollment. Selective Service is verified via FAFSA and/or military service.

#### 5. Total Number of Students who Received Emergency Grant

As of April 24, 2020, 138 students received Emergency Financial Aid Grants.

#### 6. Methods Used to Determine Amount and Recipients of Emergency Financial Aid Grants

The institution evaluated the current number of enrolled students (including students participating in temporary distance education and students on leave of absence) and students withdrawn specifically due to COVID-19 (for instance, students who were unable to return to class as scheduled due COVID-19 closures and having exceeded 180 day maximum leave of absence). The institution divided the total student portion of the Higher Education Emergency Relief Funding evenly amongst all 138 students.

Each of the 138 students received a disbursement of \$514.58 mailed via check. Each student was contacted to confirm mailing address prior to mailing.

## 7. Instructions, Directions, or Guidance Provided by the Institution to Students Concerning Emergency Financial Aid Grants

Per Department of Education guidelines under the CARES Act, students received the following disclosure with their emergency grant check:

*Good afternoon student,*

*We are so pleased to announce that we were able to participate in the Higher Education Emergency Relief Fund (HEERF) Grant for students!*

**You may use these funds for eligible expenses to cover expenses related to the disruption of campus operations due to COVID-19. Eligible expenses include those covered under cost of attendance such as Room and Board, Personal and Transportation expenses.**

*These are grant funds, they do not accrue interest and are not required to be paid back to the school or the government. These funds will not be used by the school to satisfy outstanding tuition balance. All students will receive a check even if you are not already using financial aid. The goal of this money is to ease financial strain caused by COVID-19 closures.*

## 1. Certification and Agreement

The institution, The Chrysm Institute of Esthetics, OPE ID #: 042204-00, has signed and returned to the Department of Education, the Certification and Agreement for the CRRSAA HEERF II grant for students.

## 2. Student Portion of Grant Amount Received

The institution received grant funds for the purpose of disbursement to students on March 2, 2021 from the Department of Education pursuant to the institution's Certification and Agreement.

## 3. Total Amount of Emergency Financial Aid Grants Distributed to Students

As of March 9, 2021, The Chrysm Institute of Esthetics has disbursed all funds from the CRRSAA Emergency Financial Aid Grants to students.

## 4. Estimated Total Number of Eligible Students

As of March 9, 2021, The Chrysm Institute of Esthetics had estimated 110 students at the institution eligible to receive CRRSAA funds. The institution did not include students who were on a leave of absence nor students who were past their contract end date.

## 5. Total Number of Students who Received Emergency Grant

As of March 9, 2021, 110 students were mailed a paper check after staff had completed a thorough address-confirmation of all 110 students by having the students address their own envelope for the checks to be mailed.

## 6. Methods Used to Determine Amount and Recipients of Emergency Financial Aid Grants

Based on CRRSAA HEERF II provision requirements, the institution developed a system of awarding a larger amount of emergency grant to students with greater need. The institution developed 3 tiers of need: high need, medium need, and low need.

Students were categorized via the EFC on the FAFSA previously submitted to the institution. Students who did not submit a FAFSA were still disbursed grant funds and were categorized as “low need.”

## 7. Instructions, Directions, or Guidance Provided by the Institution to Students Concerning Emergency Financial Aid Grants

As the Department of Education did not stipulate any disclosure requirements under the CRRSAA HEERF II Emergency grants, students received no disclosure with their emergency grant funds.
